That we find upon this Town's records, that a committee was chosen by Said Town to reckon with Said Swan as Treasurer which committee in their report dated September 5.

1782 say, they have reckoned all the money they could find, that was paid into Said Treasurer's hands, & if he had paid all that was ordered him to pay out by the Selectmen of Said Town, and all the notes & orders given by Said Treasurer on the Town's behalf, with interest till the day of Said reckoning, there would remain in Said Treasurer's hands of the Town's money 36:17:3 lawful money.

At the next March meeting after Said reckoning it appears that Francis Swan Jr was chosen Treasurer; and as there is no account on record of the state of the Treasury in which it was turned over from Jonathan Swan to Francis Swan, we think it impracticable for us to determine with any degree of certainty whether any of the above sum of money is now due from Said Jonathan Swan's estate to the Town or not. But we find there is in the hands of several Constables who were ordered to pay in their collections to Jonathan Swan, as Treasurer, a sum a part of which we expect was money that was charged to Jonathan Swan in the above reckoning.
