Record of Special Town Meeting, December 20th 1909.

A meeting of the Inhabitants of the Town of Methuen qualified to vote in Elections and in Town affairs was held in the Town Hall in said Town on Monday the twentieth day of December A. D. 1909 at eight o'clock in the evening pursuant to Warrant No. 10 File 14.

The meeting was called to order by Granville E. Foss, Moderator, at the time named in the Warrant, and the Warrant for the meeting was read by the Town Clerk.

It was voted to consider Article Three of the Warrant.

Article 3 Mr. Peirce moved, "That the Selectmen be authorized and instructed to prepare a division of precinct one, as now constituted, into three convenient voting precincts; generally speaking, one to consist of the west portion of the Town, one of the east portion of the Town, and one the balance of precinct one being that portion of the Town generally known as Methuen Village; said precincts to be designated as precincts one, three and four, each precinct to contain as nearly as may be, an equal number of voters, and to consist of compact and contiguous portions of territory, and bounded as far as possible by the center line of known streets or ways or other well defined lines, due regard being had for the convenience of the voters of each precinct in reaching the polling place; and to file a report of their doings with the Town Clerk with a map or description of the bounds of said precincts and the number of registered voters in each precinct at the last annual meeting, said report to be presented to the Town, for action thereon at some special or adjourned meeting or at the next Annual Town Meeting; and to make necessary arrangements for the holding of elections in each precinct, and to appoint the customary election officers for each precinct and to take other necessary action in the premises." Mr. Parker moved that Precinct One be divided with two voting precincts instead of three but the motion was lost.

The motion made by Mr. Peirce was then carried.

Article 1 Article One of the Warrant was next taken up.

The new charter proposed by the Committee had been printed and was distributed among the voters.

Mr. Kimball G. Colby reported for the committee and explained the principal points in the proposed charter.

Mr. Peirce moved that such portion or portions of the report of the Committee appointed to draw up an act of the Legislature for a revision of the present town government of Methuen, as shall be so ordered; be put into proper form by said Committee and he presented to the Attorney General of the State for his legal opinion as to whether or not it is contrary to the Constitution of the State in any respect, and that such portion thereof as shall not be contrary to the Constitution, of the State in any respect, and that such portion thereof as shall not be contrary to the Constitution, be submitted to the next Legislature for its action thereon, and that when this meeting adjourn it do so to meet again on Jan. 8, 1910 to vote by ballot on the acceptance or rejection of the report as adopted to-night; the polls to be opened at 2 o'clock P.M. and to close at 9 o'clock P.M. If adopted to be presented to the next Legislature for its action thereon. After some discussion the motion was put to vote, and was lost - Ninety two persons voting in favor, and one hundred and fifty three against.

Article 2 Voted to Article Two of the Warrant.

Voted: to appropriate one hundred dollars to reimburse the Committee on Town Government for the actual expenses incurred by said Committee.

Article 1 A motion was made to accept the report of the Committee on Town Government. Mr. Oliphant moved as a substitute motion that the report be referred back to the Committee for further consideration and to report thereon at the next annual meeting, and the motion was carried.

Voted – that a vote of thanks be presented to the Committee for their services.

A discussion of the charter was carried on by several persons and it was voted that Sections one to three be approved by the meeting.

After further discussion it was voted to adjourn to Wednesday December 29th at eight o'clock P.M.

Essex SS:- To Albert B. Gordon, one of the Constables of the Town of Methuen in said County:

Greeting:

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of the Town of Methuen qualified to vote in elections and Town affairs to meet and assemble at the designated polling places of Precinct One and Two, namely – the Town Hall in voting precinct One, and the basement of the Arlington School house in voting Precinct Two, on Monday, the seventh day of March next, at five forty-five in the forenoon, to bring in to the election officers their notes for Town Clerk, Treasurer, Collector of Taxes, Selectmen, Overseer of the Poor, one Assessor to serve three (3) years in place of Millard F. Emerson, Highway Surveyor, one School Committeeman to serve three (3) years in place of Robert B. Fisher, one Water Commissioner to serve three (3) years in the place of James H. Lyons, one trustee of Nevins Memorial to serve two (2) years in place of Alfred H. Wagland,

one Cemetery Commissioner to serve three (3) years in place of Hugh C. Smith, one Moderator to serve for one (1) year, one Auditor, Constables, Fence Viewers, and Yes or No in answer to the question: "Shall license be granted for the sale of intoxicating liquors in the Town?" All to be voted for on one ballot.

The Polls may be closed at four (4) o'clock P.M. Also to meet at the Town Hall in said Town on Saturday, the twelfth day of March next, at one (1) o'clock in the afternoon, then and there to act upon the following articles viz.:-

- Article 1 To elect all Town Officers not required to be chosen by ballot.
- Article 2 To hear the annual report of the Selectmen and act thereon.
- Article 3 To raise such sums of money as may be necessary to defray charges for the ensuing year and make appropriations for the same.
- Article 4 To determine the manner for collecting taxes the ensuing year and act thereon as the Town may think proper.
- Article 5 To see if the Town will vote to authorize the Town Treasurer with the approval of the Selectmen, or a majority thereof, to borrow during the municipal year beginning January first 1910, in anticipation of the collection of taxes of said year such sums of money as may be necessary for the current expenses of the town, but not exceeding the total tax levy for the said year, giving the notes of the town therefore, payable within one year from the dates thereof. All debts incurred under authority of this vote shall be paid from the taxes of the present municipal year.
- Article 6 To hear the reports of Committees and act thereon.
- Article 7 To determine the manner of appropriating the amount received from Dog Taxes in accordance with Chapter 102, Section 163 of the Revised Laws.
- Article 8 To determine what compensation in the Town will grant the members of the Fire Department for their services the ensuing year.
- Article 9 By request of Edward A. Bower and others, to see if the town will vote to accept the provisions of Section 37 of Chapter 19 of the Revised Laws in so far as it relates to the regular and permanent police force.
- Article 10 By request of Col. William B. Greene Post No. 100, G. A. R., to see if the Town will vote to appropriate the sum of two hundred (\$200) dollars for decorating the graves of our Soldiers and Sailors on Memorial Day, May 30, 1910. Said money to be expended under the direction of the above post.
- Article 11 By request of the Committee on Town Government, to see if the Town will vote to adopt the

following as a by-law of the Town: “The annual salary of each of the Selectmen shall be \$300.00 per year, payable monthly in equal instalments [installments]. The office of the Selectmen shall be open daily, excepting Sunday, from 9 A.M. to P.M., and from 2 to 5 P.M., and on at least one evening in each week from 7 to 9 P.M. The Selectmen shall hold a regular public meeting at least once a week, and may employ clerical assistance at an expense not to exceed \$800.00 per year.

- Article 12 By request of the School Committee to see if the Town will vote to instruct the School Committee to erect an eight-room brick building upon the Oakland Avenue lot, and a six-room brick building upon the Broadway lot adjacent to the present Arlington School; and appropriate \$73,000 for the same.
- Article 13 To see if the Town will vote to borrow money to pay for the construction and furnishing of the school house voted to be built the present year, and authorize the issue of the note or notes of the town therefor.
- Article 14 By request of M. Lodge and others, to see if the Town will build a fire station in the vicinity of Cook’s Corner, in the east end of the Town, and appropriate a sum of money for the same. Said appropriation to be met by bonds or notes issued by the Town.
- Article 15 To see if the Town will vote to pay the Clerk for the Town Treasurer and Collector, ten dollars per week, and make an appropriation for the same.
- Article 16 By request of G. A. Lewis and others to see if the Town will vote to pay for the Drivers of the Board of Health teams, twenty-five cents more per day for their services.
- Article 17 By request of Millard F. Emerson and others to see if the Town will vote to extend the water pipe on Pelham Street from Marsh Corner to the junction of Pelham Street and Hampshire Roads and up Hampshire Roads about (800) eight hundred feet and appropriate five thousand (\$5,000.00) dollars, for the same.
- Article 18 To see if the Town will vote to borrow money to pay for the extension of the water pipe up Pelham Street and Hampshire Roads and authorize the issue of the note or notes of the Town therefor.
- Article 19 By request of the Highway Surveyor, to see if the Town will vote to purchase a new Stone Crusher and appropriate fifteen hundred (\$1,500.00) dollars for the same.
- Article 20 By request of C. A. Stevens and others to see if the Town will vote to purchase five hundred (500) feet of hose and reel for same, to be used on Pelham Street in case of fire and appropriate five hundred (\$500.00) dollars for the same.
- Article 21 By request of William Hoepfner and others, to see if the Town will vote to give the Pleasant View District 250 feet of hose and appropriate \$125.00 for the same.
- Article 22 By request of William Hoepfner and others to see if the Town will vote to appropriate twenty-five dollars for a chemical to be placed on the hose reel.

- Article 23 By request of Asa L. Harris and others to see if the Town will vote to install in the Central Fire Station a "Gamewell's Universal Box", and appropriate two hundred (\$200.00) therefor.
- Article 24 By request of the Fire Engineers, to see if the Town will vote to appropriate one thousand (\$1000.00) dollars for Fire Hose.
- Article 25 By request of M. Lodge and others, to see if the Town will vote to buy three hundred feet of hose to be located at Fairview and appropriate one hundred and fifty dollars for the same.
- Article 26 By request of George C. Oliver and others to see if the Town will vote to install a fire alarm box at Hampshire Roads near the residence of George C. Oliver and appropriate the sum of \$350.00.
- Article 27 By request of Frederick A. Hoyle and others, to see if the Town will vote, for the better protection of Fire Service in Methuen, by equipping hydrants for inspection by adopting the Brown and Haycock system or other method equally reliable, so that freezing of hydrants may be prevented and appropriate eighteen hundred (\$1800.00) dollars for same.
- Article 28 By request of Maurice Flahive, to see if the Town will vote to sell to Maurice Flahive, a part of the land purchased from the Methuen Company adjoining land of said Flahive and act thereon.
- Article 29 By request of Edwin J. Castle and others, to see if the Town will vote to accept the plan and adopt the recommendation of the County Commissioners as regards the widening of Lowell Street from Hampshire Street to the Railroad bridge and appropriate the sum of \$6,000.
- Article 30 By request of James H. Lyons and others, to see if the Town will vote to drop the word Extension from that part of Oakland Avenue, west of Lowell Street and name the whole street Oakland Avenue.
- Article 31 To see if the Town will vote to keep the horse of the Street Commissioner in addition to his salary and make an appropriation for the same.
- Article 32 By request of A. W. Phippen and others, to see if the Town will vote to have all police officers special or otherwise, while on duty clothed in regulation uniform.
- Article 33 By request of the Committee on Town Government, to see if the Town will vote to amend Section 11 of the By-Laws of the Town as published in the Annual Report of the Selectmen for 1908, to read as follows: The financial year shall begin with the fifteenth day of March in each year, and shall end with the fourteenth day of March in the succeeding year.
- Article 34 By request of the Committee on Town Government, to see if the Town will vote to adopt the following as a by-law of the Town: The Town Auditor shall examine once each month, the books and accounts of all officers and committees who are entrusted with the receipt, custody or expenditure of money, and all the original bills and vouchers on which the town money may be expended, and shall on or before the tenth day of each month, report the result of his examination to the Selectmen, and shall cause to be published in some newspaper published in the Town or in the City of Lawrence, a detailed statement showing the receipts and expenditures of each

department during the preceding month, the total receipts and expenditures of each department during the preceding months of the fiscal year, and the appropriations therefor made by the Town, together with the amounts of any unpaid bills, and the amounts due on any unfinished contracts. He shall receive an annual salary of \$200.00 payable monthly in equal instalments. Any by-law, or portion thereof, inconsistent herewith is hereby repealed.

- Article 35 By request of the Committee on Town Government, to see if the Town will vote to adopt the following by-law: The Selectmen shall annually, after their election, appoint a legal resident of the Town as Town counsel, to take office on the first day of May for the term or one year, or until his successor is appointed, to perform the duties usually involving upon such officer, at the annual salary of three hundred (\$300.00) dollars per year, payable monthly in equal monthly instalments.
- Article 36 By request of Harriette F. Nevins and others, to see if the Town of Methuen will vote to extend the water pipe from the corner of Broadway and Hampshire Street up Hampshire Street about twenty-one hundred feet north and appropriate twelve (\$1,200) hundred dollars for same.
- Article 37 By request of William A. Benoit and others, to see if the Town will vote to extend its water main long Pleasant Valley Street from Merrimack Street to the residence of Mr. Long, a distance of twenty-two hundred feet and appropriate (\$2,200) two thousand two hundred dollars for the same.
- Article 38 By request of Conrad Puchtler and others, to see if the Town will vote to extend the water main on Merrimack Street from the residence of George Cross to Alvin Street and appropriate the sum of six hundred dollars for same.
- Article 39 By request of James Watt and others, to see if the Town of Methuen will vote to extend its water system as follows: From the corner of Howe and Currier Streets through Currier Street to Washington Street, a distance of about three thousand six hundred and fifty (3,650) feet; thence northeasterly along Washington Street to the residence of Henry G. Richardson, a distance of about three hundred (300) feet from Currier Street; also extend said system southwesterly from Currier along Washington Street, to the residence of Joseph Bedard, a distance of about five hundred fifty (550) feet from the corner of Currier and Washington Streets, this making a total extension of about four thousand five hundred (4,500) feet, and appropriate four thousand five hundred (\$4,500) dollars for the same.
- Article 40 Be request of Otis Allen and others to see if the Town of Methuen will vote to extend the water main from its end at 172 Howe Street to 247 Howe Street and appropriate the sum of \$3,750.00 for the same.
- Article 41 By request of C. E. Young and others to see if the Town will vote to lay water pipes from corner of North Lowell and Lowell Streets to corner of North Lowell and Tyler Streets about 2500 feet and appropriate twenty-five hundred dollars for the same.
- Article 42 By request of Samuel Robinson and others, to see if the Town will vote to extend its water service on Albion Street 700 feet from Milk Street and appropriate \$700.00 for the same.

- Article 43 By request of V. B. Richardson and others to see if the town will vote to extend the water supply from Mr. Sherman's to Governor's School, about 7200 feet and appropriate seven thousand (\$7,000) dollars for the same.
- Article 44 By request of Peter W. Maguire and others, to see if the Town will vote to extend the water from Oakland Avenue to Thornfield Avenue, a distance of about 800 feet and appropriate \$750.00 for the same.
- Article 45 By request of Alfred Griffiths and others, to see if the Town will vote to extend the water pipes of its system of water works from the corner of Prospect and East Streets westerly through East Street to Jackson Street, thence southerly through Jackson Street to Longwood Drive, so called; thence westerly through said Longwood Drive, and appropriate the sum of \$2,000.00 for the same.
- Article 46 By request of Charles R. Bower and others, to see if the Town will vote to build a retaining wall on the west side of Union Street from the corner of Oakland Avenue, one hundred feet north, and appropriate one hundred dollars to pay for the same.
- Article 47 By request of John D. Emerson and others, to see if the Town will vote to pay a salary of \$200 to the Town Auditor and appropriate money for the same.
- Article 48 By request of Isaac C. Brown and others, to see if the Town will vote to repair the macadam between Maple Street and Grosvenors Corner and appropriate five hundred (\$500) dollars for the same.
- Article 49 By request of Isaac C. Brown and others, to see if the Town will vote to macadamize North Street between Grosvenors Corner and the Salem line and appropriate twenty-five hundred (\$2,500) dollars for the same.

By the strictest economy and considerable gratuitous labor, nearly one half of the plot has been graded and with very little expense can be made ready for use. We recommend the appointment of a Committee to be known as The Playstead Commission, Said Commission to have full control of all playgrounds and parks within the town limits, and be responsible

for the expenditure of such funds as may be appropriated by the voters of the town for the development and maintenance of said playgrounds and parks. This Commission to consist of five members and be appointed annually at the annual town meeting in March of each year. We also recommend the appropriation of \$700.00 for the further development and maintenance of such playgrounds as are now owned by the Town.

Voted that for the first hour after an alarm of fire the compensation be one dollar per hour, and for every subsequent hour fifty cents.

Article 9 Civil Service Police

A motion to accept the provisions of Section 37 of Chapter 19 of the revised laws was decided in the negative and said provisions were not accepted.

Article 10 Memorial Day \$200

Voted to appropriate the sum of two hundred dollars for decorating the graves of our Soldiers and Sailors on Memorial Day, May 30, 1910. Said money to be expended under the direction of the above Post.

Article 11 By Law

A motion to amend by striking out 300 and inserting 400 was lost. A motion to make the time from 9 A.M. to 12 noon instead of 9 A.M. to 1 P.M. was also lost. A motion to insert the words "legal holidays" after the word Sunday was carried, and the word "may" was also stricken out.

A motion to adopt was carried and as amended the proposed By Law reads as follows:- "The office of the Selectmen shall be open daily excepting Sunday and legal holidays from 9 A.M. to 1 P.M. and from 2 to 5 P.M. and on at least one evening in each week from 7 to 9 P.M. The Selectmen shall hold a regular public meeting at least once a week, and employ clerical assistance at an expense not to exceed \$800.00 per year."

Voted, that the compensation of the Selectmen be three hundred dollars per annum, payable in equal monthly instalments, to be taken from the appropriation for Town Officers.

Article 12 School Houses \$75,000.00

Voted – to instruct the School Committee to erect an eight room brick building upon the Oakland Avenue lot, and a six room brick building upon the Broadway lot adjacent to the present Arlington School; and also Voted - to appropriate Seventy five thousand dollars for that purpose.

After considerable discussion it was voted to reconsider the action taken on Article 37 and 38. It was then voted to lay on the table, Articles, 37, 38, 39, 40, 41, 42, 43, 44, and 45, all relating to extension of water pipes.

On motion of Norman C. Lyon, it was voted that the votes name a Committee of three, consisting of Mr. Bunting, Mr. Holt, and Mr. Pierce, and one other to be name by the Moderator, to draft a bill to be presented to the Legislature, to cover any expenditure of money that may be made this year in extending the water system of Methuen. This Committee to report at the first adjournment of this town Meeting.

The Moderator appointed Joseph S. Howe as the fourth member of the Committee.

Voted – to adjourn the meeting for one week – to Saturday March 19th at one o'clock and thirty minutes P.M.

Voted – that the Street Commissioner repair Railroad Street near the Cemetery, and that one hundred dollars be appropriated therefor.

Voted – that the Street Commissioner repair Alvin Street the expense to be taken from the regular appropriation

Article 52 **Sidewalk Merrimack \$50.00**

Voted, - to extend the sidewalk on Merrimack Street from Combination Street to the Boundary line, and appropriate Fifty Dollars therefor.

Article 13 **School House Loan**

Article 13, was taken from the table and it was,

Voted by a unanimous vote

That for the purpose of paying for the construction and equipment of the school house voted to be built on the Oakland Avenue lot, and the Broadway lot, the Town Treasurer is hereby authorized and directed to borrow with the approval of the Board of Selectmen the sum of

Seventy five thousand dollars, and to execute and deliver the notes of the Town therefor payable as follows; Three thousand dollars, in each year from ten to fifteen years from the date of issue, Four thousand dollars in each year from the date of issue, and Five thousand Dollars in each year from fifteen to twenty years from the date of issue, with interest thereon at the rate of four per cent per annum payable semi-annually. The funds necessary to pay off said loan at maturity to be raised annually by taxation in proper amounts, so that a fund will be raised and set apart yearly sufficient to extinguish the debt at Maturity.

Article 5 **Sewer Loan**

Article 5 was taken from the table and it was Voted, - by a unanimous vote, -

That the Treasurer be and he hereby is authorized, with the approval of the majority of the Selectmen, to borrow from time to time during the current municipal year, beginning Jan. 1, 1910, in anticipation of the taxes of said municipal year a sum or sums not exceeding at any one time outstanding One Hundred Thousand Dollars for the purpose of meeting the current expenses of the Town, and to give the notes of the Town therefore, payable within one year from their dates. All debts incurred under authority of this vote shall be paid from the taxes of said current municipal year.

Said notes shall not be valid unless authorized by the certificate of the First National Bank of Boston.

Voted, - that the recommendation of the Finance Committee be adopted, and that the Street Commissioner round up and gravel the road and that the sum of Five Hundred Dollars be appropriated therefor.

Article 55 **Pleasant Valley St. \$200.00**

Voted, - to adopt the recommendation of the Finance Committee and that the Street Commissioner round up the road and gravel the same from Hill’s driveway to Jackson’s driveway, and that two hundred dollars be appropriated therefor.

Article 56 **Lowell St. \$1,000**

Voted, - to appropriate the sum of One Thousand Dollars to grade and gravel Lowell Street, from the residence of Mrs. Newsholme as far as that sum of money will pay for the work.

Article 57 **Webb Street \$100.00**

Voted, - to appropriate the sum of One Hundred Dollars to build sidewalks on Webb Street.

Article 58 **Riverdale St.**

Voted, to refer Article 58 to the Street Commissioner to make such repairs as he shall think necessary.

Article 59 **North St.**

Voted to pass over Article 59 of the Warrant.

Article 60 **Cross St. \$500.00**

Voted, - that the Street Commissioner be instructed to expend Five Hundred Dollars for repairs on Cross Street, and that Five Hundred Dollars be appropriated for that purpose.

Article 61 **Ashland Ave. \$300.00**

Voted – to construct two catch basins at the junction of Ashland Avenue and Craven Street and pave the gutters of said Ashland Avenue from Craven Street to the brow of the hill a distance of about four hundred feet and appropriate three hundred dollars for that purpose.

Article 30 **Water**
& 45

Voted – to take Articles 30 to 45 from the table, and that money appropriation under Article 18 be included.

Voted that the Committee to petition the Legislature for authority to issue Thirty Five Thousand dollars. No further action was taken on the articles named.

Article 62 **Lowell St.**

It was voted to refer the subject matter of Article 32, to the next Annual Town Meeting.

Article 63 **Meat Inspector \$500.00**

Voted to pay the Meat Inspector a salary of Five Hundred Dollars per Annum and that Five Hundred Dollars be appropriated for that purpose.

Article 64 **Police – Pleasant Valley**

Voted – To pass over Article 64 of the Warrant.

Article 74 **Sewer**

It was next voted to consider Article 74 of the Warrant; and it was voted to pass over the article.

The meeting was the adjourned to Saturday March 26th at half past one P.M.

An adjourned meeting of the Inhabitants of the Town of Methuen was held at the Town Hall, on Saturday, March twenty sixth at half past one, the Moderator in the chair.

Article 65 **Arnold St. \$500.00**

A motion to pass over the Article was declared lost; it was then Voted, - to have the gutters paved and necessary catch basins fixed on Arnold Street, and Five Hundred Dollars was appropriated for that purpose.

Article 66 Voted – to lay Article 66 on table for one hour.

Article 67 **Overseers of the Poor**

It was voted to adopt Article sixty seven as a vote of the Town but not as a By-Law, The vote was as follows;

Voted – that the Overseers of the Poor shall annually after the election in March, appoint as a Town Physician, a physician who is a legal resident of the Town to take office on the first day of May for the term of one year or until his successor is appointed, whose duties it shall be to render, under the direction of the Overseers of the Poor, proper medical and surgical treatment, and to furnish all needed medicine and appliances as it shall be necessary, to all who shall, during the period of his appointment require medical or surgical treatment from the town, including paupers for whose support and treatment the town receives remuneration from any other city or town or from the State. The annual salary of such Physician shall be \$600.00, payable in equal monthly installments the first day of each month.

Article 68 **Town Govt.**

Voted – to pass over Article 68 of the Warrant.

Article 69 **Town Government**

Voted – to pass over Article 69 of the Warrant.

Article 28 **Land Exchange**

Article 28 was taken from the table, and referred to the Selectmen, with full power to make exchange of land of equal value, and sign deeds of transcript, if in their judgment expedient.

Article 70 **Elmwood \$600.00**

Considerable discussion took place on the subject contained in the Article, and the meeting refused to appropriate Two Thousand Dollars. The meeting then voted to appropriate Six Hundred Dollars for improvements in Elmwood Cemetery.

Article 71 **Playstead \$700.00**

Before the consideration of Article 71, Mr. Humphrey, from the Playstead Committee, reported the doings of the Committee for 1909, and the report was accepted. It was then voted to appropriate Seven Hundred Dollars for further development and maintenance of such playgrounds as are now owned by the Town, and that a Committee to be known as the Playstead Commission be appointed, Said Commission to have full control of all playgrounds and parks within the town limits, and to be responsible for the expenditure of such funds as may be appropriated by the voters of the town for the development, and maintenance of said playgrounds and parks.

Voted to appoint the same Committee as served last year with the addition of Arthur W. Phippen. The Committee consists of Arthur J. Crosby, Alfred Humphrey, George W. Tenney, Robert W. Tenney, Robert W. Dow, Josiah W. Bodwell, Albion G. Pierce, Joseph S. Howe, Arthur W. Phippen, and J. Milton Tenney.

Article 72 Voted to pass over Article 72 of the Warrant.

Article 73 **Driver's Pay**

Voted to pay the men that drive or furnish a team the same as the laborers, making five dollars per day for a team. Voted; that all drivers be paid two dollars per day

Article 66 **Revolutionary Memorial - Elmwood**

Article 66 was taken from the table.

Charles M. Sawyer presented and read the report of the Commonwealth which is as follows:-
“Your Committee would respectfully report, - that it seems to be the opinion of the citizens that some memorial be erected.

The only difference of opinion is as to the form the memorial shall assume. A bronze tablet on a boulder was the form first considered, but it has been called to our attention, that such a tablet when once erected cannot be changed and if it should occur that other names be brought forward, it will be impossible to insert them; while a granite tablet may be added to at small expense at any time. A granite die about 3 feet square, on a granite base four feet square by two feet high, with all inscriptions will cost about Three Hundred Dollars, all set in position; a bronze tablet on a boulder will cost about the same amount.

Voted to extend the water main on Merrimack Street, from the residence of George Cross, to Alvin Street, and appropriate the sum of Six Hundred Dollars for the same.

Article 9 **Water Currier St. \$4500.00**

Voted,- to extend the water system, from the corner of Howe and Currier streets, through Currier street to Washington Street, a distance of about thirty six hundred and fifty feet, thence northeasterly along Washington Street to the residence of Mr. Henry G. Richardson, about three hundred feet; Also along Washington Street to the residence of Joseph Bedard about five hundred and fifty feet, and appropriate the sum of forty five hundred dollars for that purpose.

Article 10 **Patrolman \$500.00**

Voted:- to sustain the action of the Selectmen in placing a day patrolman about the town, and appropriate the sum of five hundred dollars for that purpose, said sum to be added to the regular appropriation for Police.

Article 11 **Water - Merrimack \$2600.00**

Article 13 **Playstead**

Voted - to pass over Article 13 of the Warrant.

Voted: - that any unexpended balances from the appropriation for water extension, be reserved for future extensions.

Article 14 **Sewer – East St. \$250.00**

Voted: - to construct two hundred and fifty feet of 8 inch sewer on East St. and to appropriate two hundred and fifty dollars therefor.

Article 15 **Loan**

Voted: - by a unanimous vote, that for the purpose of paying for the construction of a sewer in East Street, the Town Treasurer is hereby authorized and directed to borrow with the approval of the Board of Selectmen, the sum of two hundred and fifty dollars and to execute and deliver the note or notes of the Town, therefor, payable in ten years from the date of issue with interest thereon at a rate not exceeding four and one half per cent, per annum payable semi-annually. The funds necessary to pay off said loan at maturity to be raised annually by taxation in proper amounts to extinguish the debt at maturity.

Article 16 **Patrolman**

Voted to pass over Article 16 of the Warrant.

Article 17 **Street fights**

Voted: - to pass over Article 17 of the Warrant

Article 18 **Industrial School \$1000.00**

Voted – to appropriate One Thousand Dollars to pay tuition charges of the Lawrence Industrial school for instruction of Methuen Residents.

Voted - That the Water Board be requested to print in their Annual Town report, the amount expended on each extension made, where the expenditure is over fifty dollars.

Voted: - to instruct the Selectmen to divide the Town into additional voting Precincts.

Article 1 School House Loan

The Town Clerk stated that the subject matter of the article was acted upon at the Annual Town Meeting, but that a defect in the vote was found, which made a new vote necessary.

It was then voted by a unanimous vote:-

That the School Committee be and it is hereby instructed to erect an eight room brick school house on the lot owned by the Town on Oakland Avenue, and a six-room brick school-house upon the lot owned by the Town upon Broadway adjacent to the present Arlington School.

For the purpose of raising the money necessary for the foregoing purposes, the Town Treasurer is hereby directed to issue and sell notes or bonds of the Town, coupon in form, to the amount of seventy five thousand (\$75,000.00) dollars, bearing interest at a rate not exceeding four and one half per cent, and payable in annual installments of four thousand (4,000) dollars each beginning one year from the date of said notes or bonds and continuing for fifteen successive years, and three thousand dollars each, beginning sixteen years from the date of said notes or bonds and continuing for five successive years; and the proceeds of said notes or bonds are hereby appropriated for the purpose aforesaid. Said notes or bonds shall be payable, principal and interest, at the First National Bank of Boston, and shall bear the authenticating certificate of said Bank.

Article 2 Monument Lot

Voted:- to accept from Charles H. Tenney, a deed of the monument lot on Pleasant Street, upon the conditions specified in said deed.

Voted: that a vote of thanks be given to Mr. Tenney for his generous gift. The vote was taken by a rising vote and was unanimous.

A motion was then made to pass over the Article, and the motion was lost – seven in favor to nine opposed.

A motion was then made to appropriate Seven Hundred Dollars for the purchase of the land, that sum to be taken from the income of the waterworks, and the motion was lost.

The question then recurred on the original motion, and it was voted to purchase the lot from the Methuen Company, and appropriate Seven Hundred Dollars for that purpose.

No other business appearing, the meeting adjourned.
